Course Entry Criteria

Counselling or Psychotherapy diploma qualification by a recognised body.

3 years minimum post qualifying counselling experience or 300 (post qualifying) hours or more of client hours.

BACP/UKCP/BAPT membership or equivalent governing body.

Access to 1 or 2 supervisee's per month of 1.5 hours.

Minimum 80% Course Attendance required
